Stanley Black & Decker has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure effective August 28, 2026, through December 30, 2026, with the final, anticipated date of December 30, 2026. The affected location is located at 241 Commerce Way, Gallatin, TN 37006. The total number of affected workers is 116. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on June 24, 2026.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of, and the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
