



# Percentage of High School Students Who Rarely or Never Wore a Seat Belt,\* 1993-2017<sup>†</sup>




# Percentage of High School Students Who Rode with a Driver Who Had Been Drinking Alcohol,\* 1993-2017<sup>†</sup>



# Percentage of High School Students Who Texted or E-Mailed While Driving a Car or Other Vehicle,\* 2013-2017<sup>†</sup>






















# Percentage of High School Students Who Felt Sad or Hopeless,\* 2003-2017<sup>†</sup>




# Percentage of High School Students Who Seriously Considered Attempting Suicide,\* 1993-2017<sup>†</sup>






### Percentage of High School Students Who Attempted Suicide,\* 1993-2017<sup>†</sup>








# Percentage of High School Students Who Ever Tried Cigarette Smoking,\* 1993-2017<sup>†</sup>









# Percentage of High School Students Who Currently Smoked Cigarettes Frequently,\* 1993-2017<sup>†</sup>







# Percentage of High School Students Who Smoked More Than 10 Cigarettes Per Day,\* by Sex, Grade, and Race/Ethnicity, 2017





# Percentage of High School Students Who Ever Used an Electronic Vapor Product,\* 2015-2017<sup>†</sup>



# Percentage of High School Students Who Currently Used an Electronic Vapor Product,\* 2015-2017<sup>†</sup>









# Percentage of High School Students Who Currently Smoked Cigarettes or Cigars,\* 2003-2017<sup>†</sup>






























### Percentage of High School Students Who Had Obesity,\* 2003-2017<sup>†</sup>


# Percentage of High School Students Who Were Overweight,\* by Sex, Grade, and Race/Ethnicity, 2017



# Percentage of High School Students Who Described Themselves As Slightly or Very Overweight, by Sex,\* Grade, and Race/Ethnicity,\* 2017





# Percentage of High School Students Who Described Themselves As Slightly or Very Overweight, 1993-2017<sup>\*</sup>





# Percentage of High School Students Who Were Trying to Lose Weight, by Sex,\* Grade, and Race/Ethnicity, 2017








# Percentage of High School Students Who Did Not Drink Fruit Juice,\* 2003-2017<sup>†</sup>


















# Percentage of High School Students Who Did Not Eat Green Salad,\* 2003-2017<sup>†</sup>




# Percentage of High School Students Who Did Not Eat Potatoes,\* 2003-2017<sup>†</sup>









# Percentage of High School Students Who Did Not Eat Vegetables,\* 2003-2017<sup>†</sup>





# Percentage of High School Students Who Ate Vegetables One or More Times Per Day,\* 2003-2017<sup>†</sup>



## Percentage of High School Students Who Ate Vegetables Two or More Times Per Day,\* by Sex, Grade, and Race/Ethnicity, 2017



# Percentage of High School Students Who Ate Vegetables Two or More Times Per Day,\* 2003-2017<sup>†</sup>



## Percentage of High School Students Who Ate Vegetables Three or More Times Per Day,\* by Sex, Grade, and Race/Ethnicity, 2017




















## Percentage of High School Students Who Drank Three or More Glasses Per Day of Milk,\* 2013-2017<sup>†</sup>







## Percentage of High School Students Who Were Physically Active at Least 60 Minutes Per Day on 5 or More Days,\* 2011-2017<sup>†</sup>







## Percentage of High School Students Who Were Physically Active at Least 60 Minutes Per Day on All 7 Days,\* 2011-2017<sup>†</sup>





## Percentage of High School Students Who Watched Television 3 or More Hours Per Day,\* 2003-2017<sup>†</sup>






## Percentage of High School Students Who Played Video or Computer Games or Used a Computer 3 or More Hours Per Day,\* 2007-2017<sup>†</sup>



# Percentage of High School Students Who Attended Physical Education (PE) Classes on 1 or More Days,\* 1993-2017<sup>†</sup>





## Percentage of High School Students Who Attended Physical Education Classes on All 5 Days,\* 1993-2017<sup>†</sup>







### Percentage of High School Students Who Played on at Least One Sports Team,\* 2003-2017<sup>†</sup>

















# Percentage of High School Students Who Got 8 or More Hours of Sleep,\* 2013-2017<sup>†</sup>




